

WHAT IS THE PROGRESSIVE SAFE SYSTEM (PSS)

As part of the Mayor of London's #VisionZero plan to eliminate ALL deaths and serious injuries on London's transport network by 2024, TFL have released an enhancement to the current **Direct Vision Standard** (**DVS**) 'Safe System' with the introduction of the '**Progressive Safe System**' (PSS).

From 28 October 2024 HGVs over 12T must meet a minimum standard of **three-star rating**,



KEY DATES:

Applications for DVS 'PSS' Permits accepted from: MONDAY 24 JUNE 2024

DVS 'Safe System' Permits (for 0 - 2 star HGV's) valid until: **SUNDAY 27 OCTOBER 2024**

DVS 'PSS' Permit required (for 0 - 2 star HGV's) by: MONDAY 28 OCTOBER 2024

TfL 3-month grace period ends on: TUESDAY 28 JANUARY 2025

PSS Permit valid until: MONDAY 28 OCTOBER 2030

Where vehicles do not meet this minimum standard, operators are required to implement a series of vehicle safety measures which are designed to reduce the risks that HGVs present to vulnerable road users (VRU).

With the addition of a **Moving Off Information System** (MOIS), the PSS also uses a **Blind Spot Information System** (BSIS), and a **Camera Monitoring System** (CMS) to completely eliminate the blind spot on the nearside of the vehicle.


